BYLAW No. 1/97

A BYLAW TO PROVIDE FOR THE ENTERING INTO AN AGREEMENT BETWEEN THE CITY OF MOOSE JAW AND THE VILLAGE OF MARQUIS PROVIDING FOR THE FURNISHING OF CITY FIRE FIGHTING EQUIPMENT IN EXTINGUISHING FIRES WITHIN THE BOUNDARIES OF THE VILLAGE OF MARQUIS.

The Council of the Village of Marquis in the Province of Saskatchewan, enacts as follows:

1. The Village of Marquis is hereby authorized to enter into an agreement with the City of Moose Jaw, the terms of which are attached hereto and marked exhibit "A" for the purpose of Providing for the Furnishing of City Fire Fighting Equipment in Extinguishing Fires within The Boundaries of The Rural Municipality.
2. The Mayor and Secretary Treasurer of the Village of Marquis, are hereby authorized to sign and execute an agreement, the terms of which are set out in Exhibit "A" herebefore referred to.
